



**CONDITIONS OF THE COMPETITIVE TENDER FOR THE SALE OF  
PUREBRED ARABIANS, ANGLO-ARABIANS AND PONIES  
at Michałów State Stud Ltd.  
offered for sale  
on 10th December 2022**

Michałów State Stud Ltd. announces competitive tender for the sale of purebred Arabian horses, Anglo-Arabians and ponies on 10<sup>th</sup> December 2022. The Stud invites to submit written offers until 10<sup>th</sup> December 2022 (Saturday), 1:00 p.m. There is a possibility to see the offered horses on the day of the tender in the barns between 9 and 11 a.m. At 11:30 a.m., Michałów State Stud invites everyone to the indoor arena for the presentation of the offered horses.

1. These conditions determine how the competitive tender for the sale of horses, hereinafter referred to as the competitive tender, from the herd owned by Michałów State Stud Ltd. located in Michałów, hereinafter referred to as the Stud, will be carried out.
2. The competitive tender is carried out by the three-person Tender commission, hereinafter referred to as the Tender commission.

Conditions of sale in form of offers tender

1. The competitive tender is organized by Michałów State Stud Ltd. with headquarters in Michałów (post code 28-411), hereinafter referred to as the Organizer.
2. Taking part in the competitive tender is available on equal terms without any restrictions to natural persons, legal persons or other entities possessing legal capacity.
3. Persons taking part in competitive tender are obligated to get familiar with the sale conditions, entering the bid equals to accepting the sale conditions.
4. Sale of the horses will be conducted in the form of competitive tendering – written applications submitted at the Organizer's headquarters on the day of the tender, sent by post to the Organizer's address, i.e. Stadnina Koni Michałów Sp. z o.o., 28-411 Michałów or sent via e-mail to the Organizer's email address, i.e. [office@stadninamichalow.pl](mailto:office@stadninamichalow.pl).
5. The tender will be conducted in two currencies: in Polish zlotys for the national bidders and in Euro for the international bidders. For the comparison

of the submitted offers, the average Euro exchange rate of 1<sup>st</sup> December will be used.

6. The advertisement regarding the sale of horses available in the competitive tender will be published on Stud's website. The content of the advertisement will include the list of horses offered in the competitive tender, the date for the submission of offers, the date for the opening of offers as well as the reserve price which will also be the asking price and the main criterion for choosing the offer used by the Tender commission.
7. Written application for the competitive tender must include the following information:
  - 1) name, surname, name of the company
  - 2) address (private or company),
  - 3) email address
  - 4) phone number
  - 5) name of selected horse together with its number on the list
  - 6) offered net price in EURO or PLN as well as offeror's covenanting to pay for a horse, in the case of concluding the transaction, on pick up day of a horse or no later than 14 days after closing the tender.
8. Main criterion of selecting the offer is the price offered for a horse. Each horse has a reserve/asking price determined by the Organizer and can be sold to the Buyer with the highest offer which is not lower than the reserve price.
9. The purchase price which is equivalent to the highest offer is the final net price that is non-negotiable and will be enlarged by the applicable VAT rate.
10. The Organizer reserves the right to withdraw any horse from the tender or cancel the tender without giving a reason.
11. The opening of offers will take place on 10<sup>th</sup> December 2022 at 1:10 p.m. at the Organizer's headquarters.
12. The tender allotment will take place after 1:30 p.m. on the same day at the Organizer's office.
13. The person with the highest bid will become the Buyer provided that the reserve price is met.
14. In case two equal bids are made for the same horse, an additional competitive tendering will take place between the same bidders.
15. Publication of chosen offers will take place after the tender allotment at the Organizer's headquarters and will also be sent by e-mail. The bidders that will not be present in person and will not provide the email address will be informed by phone.
16. The horse purchased in the competitive tender will only be released after the contract is signed and the total amount of the purchase price is paid.
17. The Buyer covers all the costs related to picking up and transporting the horse.
18. The Organizer is not responsible for the horses that are already paid but not picked up by the date indicated in paragraph 7 point 6.

### Informational provision for clients and associates concerning GDPR

According to art. 13 act. 1 I 2 of the Regulation (EU) 2016/679 of the European Parliament and Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free transfer of such data and repealing the Directive 95/46/WE (General Data Protection Regulation), further GDPR, the Organizer informs that:

Administrator, decisive subject about purposes and means of processing Your personal data is Stadnina Koni Michałów Sp.z o.o. (further as SK Michałów) with headquarters in Michałów, 28-411 Michałów;

Your personal data will be processed in connection to possible closing of a purchased and sale agreement, as well as, administrating offers for you within the framework of cooperation and possible vindication of claims consistent with civil law and protection against claim vindication, if such will appear;

Legal framework for processing your data are:

Art. 6 act. 1 b of GDPR — processing is necessary for realization of connecting us agreement

Art. 6 act. 1 c of GDPR — processing is necessary for realization of obligations incumbent on us on us, such as financial settlement, including taxes.

Art. 6 act. 1 f of GDPR — processing is necessary for realization of purposes coming from ours legally justified businesses, such as administrating to you offers within direct marketing and possible necessity of disproving or vindicating civil law claims;

You have right to demand from Administrator access to your personal data and to sort them, right to removing your personal data (art. 17 GDPR) or right to limit they processing (art. 18 GDPR), right to rise an objection against the data processing (art. 21 GDPR), right to relocate the data (art. 20 GDPR) or in case of obtaining approval for processing personal data, right to withhold permission at any moment (art. 7 GDPR);

You have right to press charges to supervisor organ: Director of Office of Personal Data Protection;

Your personal data will be stored through period necessary for specific data process. Data will be processed through period of standing connecting us agreement, as well as, through period of requirements concerning possible vindication of claims, so at least for 10 years from terminating the agreement- according to general limitation period included in art. 118 act from 23rd April, 1964 of the Civil Code (Dz.U.2017.459 from 2017.03.01)

Receiver of your personal data will be our employees, that are directly responsible for processing your data.

Your data might be accessed by our subcontractors, as law and informatics firms.

Your personal data will be partly processed automatically, because, to some extent we work on computers;

Handing your personal data is necessary for entering the agreement;

Your data will not be transmitted to receivers from third countries of international organizations
